KEY ADVOCACY RESULTS

AT THE CAPITOL AND IN YOUR COMMUNITY

Here are some of the areas that MREA recently provided a leadership role in successfully advocating for:

FUNDING

- Closed the Donut Hole with up to \$424 in Local Optional Revenue for all boards
- Reduced the funding gap with a highly equalized \$300 board-approved levy
- Called for equitable facility funding, worked with state task force, expect Legislative action in 2015
- Secured funding for All-Day Kindergarten programming
- Increased funding on the formula each year of the biennium

POLICY

- Repealed the GRAD rule and replaced with exams aligned with college entrance to take effect Spring 2015
- Called for state task force to address MTLE (Minnesota Teacher License Exam) reform
- Waived Basic Skills Tests for non-native English speakers who otherwise qualify for a Minnesota teaching license
- Fended off legislation tying the hands of districts when contracting for services.
- Appointment of two rural members to the board of teaching
- Science standards and graduation credits can apply to agriculture and career and technical education courses
- Conferring high school diploma is a local district decision based on students' achievement of required high school credits
- Permanent repeal of the January 15 contract deadline and penalty and safe schools maintenance of effort

LOOKING FORWARD


MREA is focused on working with the Legislature to close educational opportunity gaps in funding and policy that impacts students in Greater Minnesota.

SOME KEY ISSUES INCLUDE:

- **Provide equitable access to facility maintenance funding.** The 25 largest school districts spend \$2.79 per square foot while the other 305 Minnesota school districts and their 440,000 students spend \$0.58, one-fifth the amount.
- Increase teacher quality and availability through alternative licensing options, flexibility to teach across disciplines and specialties, and multiple strategies to measure skills.
- Provide high quality early learning programming in all counties.
- Improve the transition to college and careers by ensuring state high school course requirements better align with workforce needs.
- Balance local control and state accountability by repealing the school calendar start date requirement, and streamlining and reducing school district reporting requirements under the World's Best Workforce statute.
