It is NIS's intent to match or improve upon current benefits, and provide an option to align the administrative practices of the Consortium Member with their insurance contract. Consortium Member agrees that if the response to the RFP produces a benefit match as described above, a savings of at least 5% off their current employer-paid basic life and AD&D rates and a rate guarantee of 3 years or more Consortium Member will continue its participation in the Consortium for the duration of the guaranteed rate period of the Life insurance contract, or as otherwise required or permitted by law.

Consortium Member acknowledges that NIS will receive compensation from selected insurance carrier. Compensation amount will be disclosed during the RFP process.

Consortium Member agrees that during the RFP process and for the duration of any negotiated contract(s), it will not disclose or use any information regarding this process for any purpose that will cause harm to the integrity of the Consortium, the rates/rate guarantees of other Consortium Members or for any purpose other than as required by law or consistent with Consortium Member's operating procedures.
