Dear Parent/Guardian:

Pelican Rapids Schools provide healthy meals each day. Your children may qualify for free or reduced-priced meals. Student who qualify for reduced-priced meals will receive free breakfast and lunches. Also, all elementary students qualify for free breakfasts, regardless of their free/reduced status. Prices for school meals for the 2020-2021 school year are as follows: Breakfast---High School \$1.20, Elementary---Free. Lunch---- High School \$1.95, Elementary \$1.90. Second entrée price for high school students is \$1.55.

To apply for free or reduced priced meals, complete the enclosed Application for Educational Benefits. <u>NEW THIS YEAR!!</u> The application can also be found on the Pelican Rapids School District 548 Website. This application may be completed and emailed to Emily Evenson at <u>eevenson@vikes.us</u>. A new application must be submitted every year. Only one application is required for the entire household. The application will not be approved unless application is complete. Please make sure you have the <u>last four digits of your social security number and that the application is signed and dated</u>. Income needs to be GROSS INCOME and denoted if payment is received weekly, bi weekly, two times a month, or monthly. If no box is checked, it will be assumed that payment is received *annually*. COMPLETING THE APPLICATION WITH AN HOURLY WAGE WILL NOT BE ACCEPTED. Only farm income or Self-Employment income is recorded as NET income.

Your application also helps Pelican Rapids School District qualify for additional educational funds and discounts.

Who can get free or reduced priced meals?

Children can get free or reduced priced meals if their household income is within the maximum income allowance. If you are not sure, fill out an application and you will be notified of your meal status. Children in households participating in SNAP, MFIP and FDPIR. Benefits are extended to all children in the household when an applicant enters a case number for any household. Foster children automatically receive free meals.

FREQUENTLY ASKED QUESTIONS

- 1) <u>Will my children receive free meals if I am on WIC?</u> Children MAY be eligible for free or reduced priced meals. Please fill out an application.
- 2) May I apply if someone in my household is not a U.S. Citizen? Yes. You OR your children do not have to be a U.S. citizen for your children to qualify for free or reduced priced meals.
- 3) <u>When do I apply?</u> You should apply as soon as you receive this application. Benefits will begin immediately. Applications are accepted at any time during the school year.
- 4) <u>Who should I include as members of my household?</u> Include yourself AND any other people living in the household whether they are related or not. College students should be listed as a household member.
- 5) <u>What if my income is not always the same?</u> List the amount that you normally get. For instance, if you normally receive overtime, list it. You MAY reapply any time your income changes.
- 6) <u>Will the information I give be reviewed or checked?</u> Yes, It may. A random sample is done every year.
- 7) <u>What if I disagree with the school's decision about my application?</u> Please contact the school. You may also ask for a hearing.
- 8) <u>Do I have to fill out an application every year?</u> Yes, but benefits carryover for 30 operating days into the next school year with the same eligibility status. After 30 days, a new application must be submitted if you have previously not done so during the current school year, at which time all children in the household will revert to a full pay status.

The **Richard B. Russell National School Lunch Act** requires the information on this application. You do not have to give the information, but if you do not, we cannot approve your child for free or reduced price meals. You must include the last four digits of the social security number of the adult household member who signs the application. The last four digits of the social security number is not required when you apply on behalf of a foster child or you list a Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) Program or Food Distribution Program on Indian Reservations (FDPIR) case number or other FDPIR identifier for your child or when you indicate that the adult household member signing the application does not have a social security number. At public school districts, each student's school meal status also is recorded on a statewide computer system used to report student data to MDE as required by state law. MDE uses this information to: (1) Administer state and federal programs, (2) Calculate compensatory revenue for public schools, and (3) Judge the quality of the state's educational program.
